ENACTMENT CLAUSE

By the authority of the faith of the assembly of American Nationals, in Union under the Law of Nations, and all Acts, petitioned, accepted and acknowledged by the current United States, in Congress assembled, are hereby ordained for the safety and security of our posterity, enact the following:

SUBJECT MATTER OF THE LAW ENACTED

The United States, in Congress assembled hereby enacts the establishment of the General Post Office Exchange within The United States of America, to establish a labor backed international currency exchange online system to facilitate transactions within the General Post Office Exchange as amended 03-29-2019.

Therefore, BE IT DELEGATED, by the United States, in Congress assembled that the following bodies within the Government of The United States of America shall be delegated authority to implement the "Share Currency Exchange System" (SCES) governed by the Law of Nations, and

1. the United States, in Congress assembled
2. the office of the Governor for the Government of The United States of America
3. The General Post Master Council for Government of The United States of America
4. A three General Post Master panel in accordance with the General Post Office Articles.
5. the office of the Secretary of State for the Government of The United States of America.
6. The committee of the National assembly for the Government of The United States of America
7. General Post Office Exchange
8. Continental Public Bank

REGULATIONS OF THE STATUTE ENACTED

IT IS FORBIDDEN for anyone to violate International law and the Law of Nations.

The SCES shall be implemented as follows:

1. The buyer holding the Labor Backed Continental Dollar known as Continental Dollar-LB that desires to exchange into another currency shall buy a Share Certificate from a seller offering a Share Certificate. The Share Certificate represents a portion of the intangible property rights to a precious metal or other commodity that never changes in value.
2. The Share Certificate can be sold for another currency or held by the Buyer as investment or spent as if it were currency.
3. The Seller of the Share Certificate shall allocate a certain amount of precious metal to a third party called a Broker that facilitates any and all transactions for a fee of no more than 10 percent over and above the purchase price of the Share Certificate.

4. The seller of the Share Certificate is strictly forbidden from exchanging the Share Certificate for the precious metal and the Buyer is strictly forbidden from demanding the precious metal from the Seller. The seller is obligated to provide a Buy Out demand from the Buyer in the original currency that purchased the Share Certificate. The Buyer is not entitled to the fee for any past exchanges of the Share Certificate nor can the Buyer refuse to pay the Buy Out fee of 10 percent or lower percentage rate over and above the value of the Share Certificate. The seller, through its Broker is acting as an Automatic Clearing House for the international currency exchange and is entitled to charge a fee for the service in whatever currency is being transacted. Every time the Share Certificate is bought or sold, the Share Certificate issuer is entitled to a transfer fee over and above the value of the Share Certificate.
5. The Share Certificate itself can be traded for anything of value. If the Share Certificate is traded for something other than currency, the Share Certificate issuer is not entitled to a transfer fee.
6. A Share Certificate is not valid unless the receipt from the original Buyer is attached to the Share Certificate and the receipt is attached to the Share Certificate from any other currency exchange transaction from the Broker to maintain Chain of Title to the Share Certificate. The absence of a receipt may cause conflict of a transfer fee owed to the Broker wherein the Broker may refuse a Buy Out if demanded by the Share Certificate Holder.
7. If Buyer becomes seller of the Share Certificate, all transactions are required to be facilitated through the Broker of the Share Certificate issuer. The Buyer of the Share Certificate is the party responsible for the transfer fee owed to the Broker. In a Buy Out, the one demanding the Buy Out is responsible for the Buy Out fee charged by the Broker over and above the value of the Share Certificate.

8. The Seller is strictly forbidden from selling the Share Certificate at a profit or loaning the Share Certificate at interest. The value of the Share Certificate is always valued at face value. However, if the Share Certificate is spent complete with receipts as if it were the Continental Dollar or other currency, change may be issued by the accepting party; this type of trade is not classified as a currency exchange and the Broker is not entitled to a transfer fee.
